AGREEMENT AMENDMENT

This AGREEMENT AMENDMENT is entered into by and between the **Iowa Mathematics and Science Education Partnership** on behalf of the Iowa Governor's STEM Advisory Council whose operations center is located at the University of Northern Iowa, 214 East Bartlett Hall, Cedar Falls, Iowa 50614-0298 (hereinafter referred to as "IMSEP") and **Iowa State University**, 1138 Pearson Hall, 505 Morrill Road, Ames, Iowa 50011-2103 (hereinafter referred to as "Contractor").

<u>WHEREAS</u>, due to an additional "Tiny Techies" STEM Scale-Up Program educator professional development session which was not originally included in the budget, an accommodation under Clause 4. PROJECT COSTS ALLOWANCE AND PAYMENT of the Regional STEM Scale-Up Programming Support Agreement [HUB-NC-FY23-02] is warranted.

WHEREAS, all other terms and conditions of the original Agreement remain unchanged.

NOW THEREFORE, the parties hereto agree to the following modifications to the funding amount under Clause 4. of the original Agreement for the benefit of the STEM Region and the Iowa STEM Scale-Up Program effort as a whole:

PROJECT COSTS AND PAYMENT. In consideration of the necessary alteration to the "Tiny Techies" STEM Scale-Up Program budget, the following adjustment in allowance will be made, thus also adjusting the allocation for STEM Festivals and the F&A allowance:
